CONDITIONS OF MEMBERSHIP:

The following conditions to apply to all new membership applications:

A three (3) month waiting period from date of acceptance of membership will apply before new members are eligible to:

1. List puppies for sale on the Club's Puppy Sales Register
2. Hold a position on the Executive Committee
3. Receive Club Awards for ANKC recognised titles

CODE OF ETHICS

The following is an extension of the Code of Ethics of Dogs Queensland and deals with matters specifically applicable to Border Collies. All members of the Border Collie Club of Queensland Inc. must abide by this Code of Ethics.

1. The age of breeding stock must be over **12 months** at the time of mating.
2. Both parents should be **DNA tested for Ceroid Lipuscinosis (CL), Trapped Neutrophil Syndrome (TNS) and Collie Eye Anomaly (CEA)**, or themselves be "**Clear by parentage**". Both parents should also be **hip and elbow x-rayed and scored prior to breeding**
3. The **mating combination should not result in affected offspring**. Eg. Acceptable DNA combinations are (Clear to Clear) or (Clear to Carrier).
4. Breeders must supply photocopies of all testing results for both sire and dam with each pup.
5. Breeders must supply publications on CL, TNS, Hip Dysplasia (HD), CEA, general care, feeding, worming and vaccination to all persons acquiring a dog from them.
6. If listing litters/puppies for sale with the club, members will abide by the Border Collie Club of Queensland Inc. Rules for listing litters/puppies.

Breaches of the Code of Ethics will be dealt with by the Management Committee according to the provisions under the Constitution.

The Border Collie Club of Queensland Inc. strongly recommends that all breeding stock be thoroughly health tested.

I/We have read and understood the CONDITIONS OF MEMBERSHIP and CODE OF ETHICS as detailed on this application. As member/s of the Border Collie Club of Queensland Inc.: I/We agree to abide by these Conditions and Code of Ethics together with the Constitution of the club.
